Safeguarding Vulnerable Adults Policy

Statement of Intent

Castle Point Social Car Scheme Ltd (CPSCS) aims to ensure a consistent approach to protect vulnerable adults who use its transport services.

CPSCS recognises that its customers could be individuals experiencing abuse or neglect. This policy document aims to be meaningful to all who may need to use it.

"There can be no secrets and no hiding place when it comes to exposing the abuse of vulnerable adults".

Much has been achieved since this publication and many adults have been enabled to live safer lives. However, CPSCS's Trustee Board and workforce must be aware that the abuse of vulnerable adults occurs.

Each and every one of us needs to ensure they remain vigilant and play their part in routing out every hiding place when it comes to exposing the abuse of vulnerable adults.

Protection of Vulnerable Adults Policy

All persons have the right to live their lives free from violence and abuse. This right is underpinned by the duty under the Human Rights Act (1998) to intervene proportionately to protect the rights of citizens.

These rights include:

Article 2: 'The Right of Life'

Article 3: 'Freedom from Torture' (including humiliating and degrading treatment)

Article 8: 'Right to Family Life' (one that sustains the individual)

Any adult at risk of abuse or neglect should be able to access public organisations for appropriate interventions which enable them to live a life free from violence and abuse. If follows that all citizens should have access to relevant services for addressing issues or abuse and neglect, including the civil and criminal justice system and victim support services.

Remedies available should also include measures that achieve behaviour change by those who have perpetrated abuse or neglect'.

"Abuse is a violation of an individual's human and civil rights by any other person or persons."

This document provides a framework within which we will work together in preventing and minimizing the risk of abuse to vulnerable adults who use Castle Point Social Car Scheme Ltd.'s services.

Vulnerable Adult

A 'Vulnerable Adult' is defined by 'No Secrets' as: 'A person aged 18 years or over who is, or may be, in need of community care services by reason of mental or other disability, age or illness; **AND** who is, or may be, unable to take care of him or herself, or be unable to protect him or herself against significant harm or exploitation.'

Values

All individuals have a right to live free from abuse in accordance with the principles of respect, dignity, autonomy, privacy and equity. Vulnerable adults are entitled to exercise the same rights as others in the prosecution of criminal offences and the pursuit of civil remedies. Vulnerable adults should enjoy the same rights as others in respect of access to community transport services provided by Castle Point Social Car Scheme Ltd.

- Carry out assessments and investigations in accordance with equal opportunity principles, in a manner and setting appropriate to the understanding, degree of disability, cultural background and gender of the person(s) involved.
